Miracle Valley Ranch General Rules

Things to Bring:

- 1. **King James Bible Only** (No other bible versions will be allowed.)
- MEN: You will need 7 pairs of underwear and socks. 5 sets of work clothes. Two
 (2) sets of dress clothes. Casual clothes. Work shoes and a nice pair of shoes for church.
- 3. **LADIES:** You will need 7 pairs of underwear and socks. Bring a pair of work shoes and a nice pair of shoes for church (no more than 3 pairs of shoes per student is allowed) and proper hosiery.
- 4. **ALL:** There will be limited storage space for clothing and personal items. Each student's belongings must remain neat and organized within the area assigned to them. No excessive accumulation of personal items or clothing will be allowed.
- 5. Personal hygiene items, towels, shower shoes and sleepwear.
- 6. Complete Bedding queen bed (sheets, blanket, pillow and pillowcase). Full and twin bunk beds for children. Washed and clean.
- 7. **Proper ID:** You must bring 2 forms of identification. If you do not have 2 forms of ID, please bring your birth certificate so that we might help you obtain proper identification while you are here.

Prohibited Items: I Corinthians 6:19

- Cash (no cash allowed). All cash, debit/credit cards etc. will be held in program account or designated safe. Families will be allowed \$40.00 per week spending limit.
- 2. Drugs/alcohol/pornography/tobacco.
- 3. Radios/Audio/Video Playing Devices.
- 4. Music or movies (music and movies will be provided by Miracle Valley).
- 5. Unauthorized Medications (must be pre-authorized by Miracle Valley).
- 6. Unauthorized medicinal sleeping aides (must be pre-authorized by Miracle Valley).
- 7. **Men:** Body jewelry including earrings is not permitted. Wedding bands and watches are acceptable.

- 8. **Ladies:** Jewelry must be worn in moderation. Piercings (earrings) may only be worn in each ear. Jewelry will not be allowed to be worn in any other piercing on the body.
- 9. Vehicles (student may be allowed vehicle with restrictions in Phase 4) or bicycles
- 10. Cell Phones

Program Privileges:

Each Student will be on a <u>blackout</u> for the first <u>10 days</u> of the program. After your blackout you will receive the following communication and visitation privileges with only those persons listed on the student's "Approved Communications List" (ACL) and have been approved by Miracle Valley Staff. ABSOLUTELY NO communication with girlfriends, boyfriends, fiancés, or anyone who is in active addiction will be allowed during the entire length of the program.

Phone Privileges

- <u>Phase 1</u> One personal phone call per week on staff phone.
- <u>Phase 2</u> Two personal phone calls per week on staff phone.
- Phase 3 Three personal phone calls per week on staff phone.
- Phase 4 Personal landline phone in cabin.
 - For the sake of others, please limit phone calls to 10 or 15 minutes.
 - Staff will not send personal text messages on your behalf.
 - Additional phone calls may be earned through weekly positive action reports.
 - Personal cell phones are NOT permitted until Phase 4.
 - Students are not allowed to touch or use graduate's personal cell phones.

Visitation Privileges

Phase 2

After successfully completing Phase 1, students will be allowed one visit.
Visitors must be on students "Approved Communications List" Visitation will be
on Saturday from 10am- 4pm (unless otherwise pre-approved) Must be preauthorized by staff 1 week in advance.

Phase 3

- Student will be allowed 1 overnight visit.
- All overnight visits will be from <u>Saturday 9 AM till Sunday 9 AM.</u> (We encourage all overnight visitors to attend services at WRBC)
- Must be pre-authorized by staff 1 week in advance.

*All visitors at Miracle Valley must agree to abide by the rules of the program and be willing to subject themselves to drug and/or alcohol testing. Refusal to take a drug or alcohol test will result in the termination of the visit and the visitor will be asked to leave immediately. The visitor may also be removed from the student's Approved Contact List (ACL).

Phase 4

One day pass monthly with immediate family only (All passes will be from <u>Saturday 9:00 AM till 6:00 PM.)</u> (Exceptions to the day and time of the pass may be given by Program Director to students who have family coming to visit from out of state.) All day passes must be pre-authorized by staff 1 week in advance.

- Students will be expected to continue to abide by the rules of the program while on their passes.
- If student returns late from pass for any reason, it will result in the loss of pass privileges the following month and possible receipt of a major violation for flagrant disregard for the rules.

Mail Privileges

Students can only receive and send mail to those persons on their "Approved Communications List" (ACL).

All outgoing mail must remain open for staff inspection prior to being mailed and all Incoming mail is subject to being opened and inspected prior to student receiving it.

Walking Privileges

- Each student must stay within their boundaries during leisure time or weekly visits in accordance to their current phase privileges.
- Each student is allowed to enjoy their visitation privileges within their perspective boundaries.
- Crossing boundaries without prior approval by staff WILL result in a major violation*.

*Any major violations will result in two weeks restriction and loss of all privileges.

Church /Classroom conduct: Heb. 10:25; I Cor. 14:33,34; Psalm 1; Joshua 1:8

- 1. Bibles and a pen/paper must be brought to all services and studies.
- 2. Bibles and notebook will be brought to each service.
- 3. Classroom dress code will be business casual.

- 4. Residents will attend all services of White River Baptist Church, HOPE Addiction Classes, and activities as scheduled by Miracle Valley.
- 5. No talking or getting up during services or class time.
- 6. Students must wear their Hope Badge to all HOPE Classes and Special Meetings on church property.
- 7. All students must remain within the eye sight of Miracle Valley Staff while on church property. It is the student's responsibility not to wander off out of sight. Being out of sight is considered out of boundaries and will result in a major violation*. Graduate residents of Miracle Valley may be given special permission to be out of sight in order to fulfill ministry responsibilities only.
- 8. Residents are required to read, study, memorize and meditate in their Bibles every morning and make a journal entry **with the date** each morning prior to Morning Devotions.
- 9. If you are unwilling to spend one hour studying your Bible every day, you cannot remain in the program.
- 10. Each week you must progress further in your unit work and counseling homework. This will be monitored during your counseling sessions.
- 11. Restrooms may only be used between services with permission from staff.
- 12. Absolutely no fellowship or communication with the opposite sex is permitted. (Special permission may be given at times to the elderly within the church). Failure to comply with this rule will result in automatic dismissal!
- 13. No communication or gossiping is allowed among those in one cabin about those in the other cabin. Don't compare yourself to others. Focus solely on Christ, YOUR family and YOUR program. Each cabin will be in different stages with different responsibilities and privileges at any given time. Failure to comply with this rule will result in a major violation.
- 14. No congregating in front of or entering any cabin not assigned to your family.

 ONLY Miracle Valley staff will be allowed to enter cabins or be on Miracle

 Valley property. All visitors must be accompanied by staff.

Conversation/Behavior: (Study and follow this closely. It will be enforced!)

- 1. Our program goal is to have all conversation be Christ-like.
- 2. Griping, negative criticism, gossiping, complaining, faultfinding, and foul language will not be tolerated.

- 3. Any complaints are to be put in writing and turned in to staff to be dealt with accordingly.
- 4. Talking about old habits or lifestyles is against God's Word and is not permitted.
- 5. Punctuality to all programs and services is a requirement. You will be at every function 10 minutes before it begins.
- 6. Failure to turn in a student for the violation of rules <u>will result in your receiving the</u> <u>same punishment</u>. You are not doing anyone any favors by concealing a violation.
- 7. No sleeping or slacking off during work times.
- 8. No returning to bed after the morning Bible devotions.
- 9. Only 4 disciplinary actions are allowed for "Poor Work Performance" before loss of work scholarship. If a student loses their work scholarship, he/she will no longer be allowed to stay in the program.
- 10. A kind and courteous attitude is expected at all times.
- 11. Leaving your boundaries is prohibited without prior approval by Miracle Valley Ranch Staff.

Dress Code: I Peter 1:16; 2:9; II Cor. 6:15-17

Men's Dress Code

- 1. A minimum of a t-shirt and shorts are required for leisure time within the cabin. No inappropriate advertising.
- 2. Miracle Valley has standard dress for each service and/or function. Ask Miracle Valley Staff for details about dress code for each occasion.
- 3. No other clothing options will be allowed.
- 4. The dress code may be amended at any time as deemed necessary by the staff or director.

Women's Dress Code

- Women's dress is taught and monitored closely by Miracle Valley Staff. Please be prepared to be taught and corrected as to how you dress while you're in the program.
- 2. Miracle Valley has standard dress for each service and/or function. Ask Miracle Valley Staff for details about dress code for each occasion.
- 3. No shorts outside of cabin. No tank tops or inappropriate advertising.

- 4. No other clothing options will be allowed
- 5. The dress code may be amended at any time as deemed necessary by staff or director.

Personal Hygiene: I Cor. 14:40; II Cor. 5:20; Mark 5:15; John 11:39b

- 1. All residents must brush their teeth, comb their hair, wash their faces and put on clean clothes each morning <u>before</u> Bible devotions.
- 2. All body odors must be controlled.
- 3. Neat, clean, and combed hair is required daily.
- MEN ONLY: Hair will remain off the collar, ears and eyebrows. This means men must have and maintain a regular man's haircut. Long hair will not be permitted for men.
- 5. Sideburns are not to be worn below the bottom of the opening of the ear.

Cabin Rules: I Cor. 4:2; Matt. 25:21, 29

- 1. The cabin assigned to you, like everything else on our property, belongs to God. It must be treated as such.
- 2. Any and all theft will be grounds for immediate termination.
- 3. No furniture is to be moved into or out of the room without approval.
- 4. Any pictures, posters, photos, etc. to be brought into the home must be approved by Miracle Valley Staff.
- 5. No food is to be kept in the bedrooms unless sealed in an airtight container, which must be provided by the student.
- 6. Turn off lights when not in use.
- 7. Daily Cleaning Checklist must be done before workday begins. Failure to maintain cleanliness in cabin will result in major violation.
- 8. No animals or pets of any kind allowed in cabins.
- 9. The porch and area around your cabin must be kept neat and orderly at all times.
- 10. Beds must be made to a designated, uniform standard, and rooms must be straightened each morning before chore inspections.

- 11. Security cameras outside cabins are not to be touched at any time.
- 12. Chores will be assigned to each resident as needed. A good attitude is a must. Complete all chores and tasks without murmuring and complaining.
- 13. Daily inspections will be conducted to ensure cabins are properly maintained.
- 14. If a student is sick, they must be excused from work with a doctor's note, otherwise it will be considered an unexcused sick day. After 4 unexcused sick days a student will lose their work scholarship and will no longer be allowed to stay in the program.
- 15. Violations will be given for incomplete or poor work scholarship performance.
- 16. Students are not allowed to enter the cabins during work hours (prior to 3:30pm) without express permission from Miracle Valley Staff. This will be considered crossing boundaries without permission and will result in a major violation.

Phase 4 privileges/ Graduate Residents / Aftercare

- 1. Graduates are welcome to stay for aftercare up to 2 months as long as they continue to abide by the rules and are actively seeking employment and housing. The following are general changes to the rules and additional privileges that occur once a student successfully becomes a graduate.
- 2. Note: The following is subject to change and privileges may be revoked as deemed necessary by Miracle Valley Staff for any Graduate.
- 3. All Graduates must agree to the terms and conditions of the Aftercare Program. (i.e. GPS tracking, internet monitoring, & financial accountability.)
- 4. Phase 4/Graduates may own a vehicle; however, all vehicles will be subject to search at any time. To be used only with permission.
- 5. Graduates are required to pay the electric bill for cabin.
- 6. Graduates may own and possess a cell phone with restrictions and parameters in place by Miracle Valley Staff. (Communications with unauthorized persons is strictly prohibited and monitored.)
- 7. Personal computers, tablets, and laptops are prohibited.
- 8. Graduates may be out of staff sight at church only if involvement in a ministry requires their presence.

Attitude:

Every person at our home is expected to be committed to and give complete dedication to living the highest quality Christian life possible. Your attitude must reflect this in the following manner:

- Gratefulness to God and the church
- Humility toward your fellow peers and the staff of Miracle Valley
- Willingness to be corrected and taught
- Readiness to change old behavior patterns
- Negative, pessimistic attitudes will not be tolerated

Each new student must complete a 30-day probationary period to the satisfaction of Miracle Valley staff before eligibility to complete the program.

4 PHASE DISCIPLESHIP PROGRAM

Phase 1 (units 1&2) - Approx. 6-8 weeks*

Apply for General Assistance within 10 days of arrival.

Complete all required step work given at the H.O.P.E. Class (5-7 Steps per week).

Attend all evening training functions.

Attend all scheduled counseling sessions.

Finish all required unit reading and counseling homework.

Read/Study the Bible daily.

Learn the current chain of command and authority structure.

• After reviewing your probationary period, you must be personally promoted to phase 2 by Ministry Director.

Phase 2 (units 3&4) - Approx. 6-8 weeks*

Complete all required step work given at the H.O.P.E. Class (5-7 Steps per week).

Attend all evening training functions.

Attend all scheduled counseling sessions.

Finish all required unit reading and counseling

homework. Read/Study the Bible daily. • You must

be promoted to next unit by staff.

Phase 3 (units 5&6) - Approx. 6-8 weeks*

Complete all required step work given at the H.O.P.E. Class (5-7 Steps per week).

Attend all evening training functions.

Attend all scheduled counseling sessions.

Finish all required unit reading and counseling

homework. Read/Study the Bible daily. • You must

be promoted to next unit by staff.

Phase 4 (units 7&8) - Approx. 6-8 weeks*

Schedule a meeting with WRBC Pastor prior to program completion.

Complete all required step work given at the H.O.P.E. Class (5-7 Steps per week).

Attend all evening training functions.

Attend all scheduled counseling sessions.

Finish all required reading and counseling homework.

Read/Study the Bible daily.

Begin working on "Exit Strategy".

*With the exception of Phase 1, anyone remaining in a Phase for more than 80 days may be subject to termination from the program.

DISCIPLESHIP HOME DISCIPLINE

Student Chastening:

Immediate Dismissal: Possession or attempted use of <u>fake urine</u>, <u>physical altercation</u>, <u>theft</u> of any kind, and <u>fellowship or communication with the opposite sex</u>, failure to be honest on the program application.

Major Offense: Possession or use of any drugs, alcohol, pornography, tobacco, intentional destruction of God's property, leaving your boundaries without permission, communicating or talking about those in the opposite cabin as you, getting the mail, touching the video surveillance cameras or camera chords, touching security keypads, flagrant disregard of general rules, insubordination or a breach in the chain of command/authority structure (listed below).

1st Offence Loss of all privileges for 2 weeks

<u>2nd Offense</u> Return to the beginning of the most recently completed

Phase and loss of all privileges for two weeks. (Possible

Termination)

<u>3rd Offense</u> Return to the beginning of Phase 1 and loss of all privileges

for two weeks. (Possible Termination)

4th Offense Termination from the program.

Minor Offense: Violation of any of the "General Rules" of the program

NOTE: The accumulation of more than 10 minor offenses in one week will result in a major violation.

"Liberty abused will be liberty lost!"

^{*} A *Major Offense* can be <u>erased</u> by completing 3 full weeks with no minor offenses. However, at the discretion of staff, termination from the program may result due to any whether it's the 1st or 4th major offense

Chain of command / Authority Structure

If a student has a grievance against a fellow student, they are to go to that student. If they are unable to clear the matter, they will write the complaint on paper and turn it in to the Ministry Director. Failure to follow "Chain of command / Authority Structure" will result in a major violation.

All grievances with anyone in authority should be brought in writing to the Ministry Director who will then mediate as necessary between the student and the person in authority to resolve the matter.

These authority figures include, but are not limited to:

Ministry Department Leader, <u>Ministry Director</u> and the <u>Staff</u> of White River Baptist Church.

In the event you feel as if your grievance was not handled properly, you may then go to the next level of authority along with the person with whom you have the grievance.

I, the Volunteer, desire to work as a volunteer for one or more of the Released Parties without compensation and engage in the activities related to being a volunteer. I understand that my activities may include but are <u>not limited to</u> the following: working at Miracle Valley Ranch offices and worksites; working in or for Miracle Valley Ranch operations; selling and making Miracle Valley Ranch products, traveling to and from work sites, towns, cities or countries; consuming food available or provided; living in housing provided for volunteers; construction-related activities; and other volunteer activities ("Activities").

I, the Volunteer, understand that my Activities may include work that may be hazardous to me, including, but not limited to, exposure to lead, asbestos, and mold, which may cause or worsen certain illnesses, especially if I do not wear protective equipment, am exposed for extended periods of time, or have a pre-existing immune system deficiency.

I also understand there is some inherent risk in consuming local foods and living in local accommodations in the city(ies) visited. I further understand I may be traveling to and from locations where there is a risk of inclement weather or other circumstances that could threaten my health or safety.

I, the Volunteer, hereby freely, voluntarily and without duress execute this Release under the following terms:

Release and Waiver. In consideration of and in order to be allowed to participate in the Activities, I, the Volunteer, do hereby release and forever discharge and hold harmless the Released Parties and their successors and assigns from any and all liability, claims, demands, costs and damages of any kind, whether arising from tort, contract or otherwise, which I or my heirs, assigns, next of kin or legal representatives may have or which may hereinafter accrue, arise from, or are in any way related to my Activities with any of the Released Parties, including but not limited to personal injury, bodily injury, illness, property damage, loss or death, whether caused wholly or in part by the simple negligence, fault or other misconduct of any of the Released Parties or of other volunteers, other than their intentional or grossly negligent conduct.

I understand and acknowledge that by signing this Release I knowingly assume the risk of injury, harm, damage and loss associated with the Activities. I also understand that the Released Parties do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.

I understand and acknowledge that children under the age of 18 are not allowed to operate machinery or power tools on Miracle Valley Ranch property without express permission from staff. While minors may be allowed to participate in some types of activities; I understand that being around machinery; using power tools; excavation; demolition; or similar activities are not permitted for anyone under the age of 18. I agree it is my responsibility to communicate these requirements to any of my minor children who will attend and/or participate in the Activities.

Consent to Transportation and Medical Treatment. I consent to the use of first aid treatment and the use of generic and over the counter medications and treatments as directed by manufacturer labels, whether administered by the Released Parties or first aid personnel. In an emergency, I understand the Released Parties may try to contact the individual listed below as an emergency contact. If an emergency contact cannot be reached promptly, I hereby authorize the Released Parties to act as an agent for me to consent to any examination, testing, x-rays, medical, dental or surgical treatment for me as advised by a physician, dentist or other health care provider. This includes, but is not limited to, my assessment, evaluation, medical care and treatment, anesthesia, hospitalization, or other health care treatment or procedure as advised by a physician, dentist or other health care provider. I also authorize the Released Parties to arrange for transportation of me as deemed necessary and appropriate in their discretion. I, the Volunteer, do hereby release, forever discharge and hold harmless the Released Parties from any liability, claim, demand, and action whatsoever brought by me or on my behalf which arises or may hereafter arise on account of any transportation, first aid, assessment, care, treatment, response or service rendered in connection with my Activities with any of the Released Parties.

Insurance. I understand that, except as otherwise agreed to by the Released Parties in writing, the Released Parties are under no obligation to provide, carry or maintain health, medical, travel, disability or other insurance coverage for any Volunteer. I understand that I am and remain responsible for payment of such hospital, physician, ambulance, dental, medical or other services obtained for me or my child. I agree that the Released Parties do not assume any responsibility for the payment of such fees or expenses which may be incurred. If I have health insurance, I understand my personal health insurance is my primary coverage.

<u>Confidentiality</u>. I agree that in the course of my participation in the Activities, I may have access to personal information of other persons.
